**Food or Drink Sales:** Any Vendor/Exhibitor wishing to hand out or sell food or drinks of any kind during the event must have prior written consent from the facility concessionaire, us & HAN as well as all proper health permits, etc.

**Space Assignment:** Placement is at our discretion. End spaces are not guaranteed.

**Refunds: NO refunds** within 45 days of event.

**Payment:** No personal or business checks will be accepted after July 1. Only cash or credit/debit cards will be accepted at the event.

**Discrepancies:** The decision of HAN Swap Meet and our employees for all discrepancies.

**Drones:** No drones allowed to be flown on or around premises.

**Vehicles:** No vehicles will be allowed to drive into the swap meet area during swap meet and spectator hours. Single occupancy handicap (ADA) approved scooters will be allowed for handicap individuals only.

**Sales Tax:** We will supply a Nevada Sales Tax Form. Please return form and sales tax to office between 2:00 and 5:00 P.M. Saturday. Nevada's Tax Rate is 8.265%. **Exhibitors are not required to hold a valid Nevada Resale License.**

**Credentials:** 2 passes will be issued for your first space and one pass will be issued for each additional space up to a maximum of 6 passes. Your wrist band must be worn at all times.

**EZ Ups:** must be weighted down with appropriate weights for possible heavy winds. Vendor will be solely liable in the event that his display causes damage to another vendor, the event site property or anyone injured due to negligence.

**Windshield Stickers:** Must be filled out and displayed on driver side windshield.

**Setup & Breakdown:** Setup Starts on Wednesday August 8th at 10am. No breaking down until 2:00 p.m.

**Generators & Noise:** Excessive stereo/display noise not allowed. No generators from 10 pm to 5am. Fire extinguishers are required with generator use.

**Security, Liability, Property Damage:** security is provided Wednesday, Thursday and Friday and Saturday the hot August nights staff and hot August nights swap meet cannot assume liability for your property. We are not responsible for merchandise loss, tooth, theft, or weather conditions.

**Camping:** overnight camping in your space is permitted. No open fires.
